### Off-Campus Practice and Teaching Bases

There are a total of 14 off-campus internship practice teaching bases for this Programme, with the main internship practice teaching bases listed in **Table 1**, which can provide students with good practical internship opportunities. Based on the talent training objectives and training program requirements, both the university and the enterprises jointly formulate the internship teaching outline, compile internship guidelines, and establish corresponding security measures. Each base is equipped with stable enterprise internship instructors who work together with university teachers to guide and manage student internships. University instructors are responsible for clarifying internship content, tasks, progress plans, schedules, and internship management regulations to students, while enterprise instructors carry out education on enterprise safety production, rules and regulations, confidentiality systems, etc., according to school requirements and actual production conditions.

## **li. Rights and obligations of Party B**

1. Each year, Party A will arrange several students to participate in a fixed-position work program lasting about 6-8 weeks at Party B. Party B will dispatch outstanding engineering and technical personnel to provide necessary guidance to the students according to the plan, while managing the students in accordance with the companys rules and regulations. Party A encourages Party B to offer certain remuneration to the students on fixed positions;

2. Party B may recruit graduates from the current year or in the future according to the talent recruitment plan of Party A in advance. The number of students with employment intention may be greater than the actual number of students recruited;

3. Party B may, according to its own needs, put forward requirements for the training plan of students who are interested in employment;

4. Party B can give priority to recruiting talents from students who participate in the industry-university cooperation education program at Party B, and Party A actively encourages these students to apply for the job.



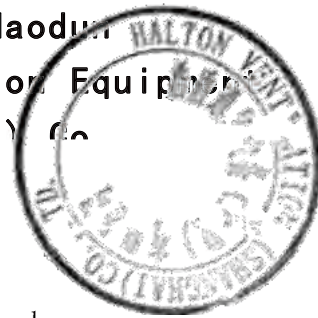
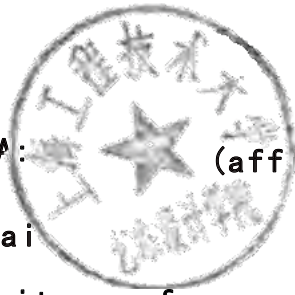

## Cooperation agreement on the establishment of off-campus internship base

Party A: Shanghai University of Engineering Technology

Party B: Hangzhou Majestic Technology Development Co., LTD

To implement the "Science and Education for City Development" strategy, we aim to follow a distinctive path of education that relies on regional industries, serves the local economy, and cultivates applied undergraduate talent. We will fully promote cooperation among schools and enterprises in industry-academia-research collaboration, making full use of off-campus internship bases to foster students practical skills and innovative spirit, thereby enhancing the quality of teaching and learning. Both parties, adhering to the principles of mutual benefit, complementary strengths, and shared development, have reached the following agreement regarding the establishment of internship bases, talent training, and technical cooperation:

1. Party B agrees to serve as the teaching internship base for students majoring in industrial design and other related majors of Party A's School of Art Design, and to assign relevant technical personnel to participate in the internship guidance of students. At the same time, Party B shall provide convenience for Party A's personnel in transportation, accommodation and food.

2. During the internship, Party A shall, in accordance with the requirements of the training plan, employ experienced engineering and technical personnel from Party B to provide students with internship guidance, special technical lectures and other knowledge training to ensure the quality of internship teaching;

6. Party A regularly invites party Bs operation, production technology, scientific research and management personnel to give academic reports. For technical personnel and management personnel who meet the requirements of dual-qualified teachers, they may be hired as part-time teachers of Party A to participate in teaching activities.
